



REPORT OF THEMATIC MEETING ON THE SURVEYS OF ODS ALTERNATIVES

November 30th – December 2nd 2016, Lake Naivasha Simba Lodge, Naivasha, Kenya

1.0 Background

The Executive Committee of the Multilateral Fund Secretariat approved the Project on Survey of ODS alternatives at the national level in 42 African countries. UNEP agreed to co-operate with the National Ozone Units in the respective countries at the national level to undertake the survey on the current consumption of ODS alternatives and provide future projections of growth patterns by substance and, to the extent feasible, by sector. The Secretariat has prepared a guide to be used as a reference in the preparation and finalization of the surveys of the ODS alternatives in Article 5 countries (UNEP/OzL.Pro/ExCom/75/77/Rev.1).

The results of the surveys are intended to enable the respective countries to have comprehensive information regarding current consumption and future trends of consumption of alternatives to ODSs in various sectors and subsectors, supply chain and availability in the market, regulatory measures regarding alternatives to ODSs and barriers to the adoption of alternative to ODSs that minimizes environmental impact taking into account energy efficiency.

UNEP/CAP partnered with the Environmental Compliance Institute (ECI) to organize a thematic meeting for African countries on the ODS surveys. The meeting was held at Lake Naivasha Simba Lodge in Naivasha, Kenya from 30th November – 2nd December 2016. By the time of the meeting some countries had already drafted their reports and submitted to CAP for review while other countries were still struggling to draft their reports.

2.0 Objectives of the Thematic Meeting

The **main objective** of the thematic meeting was to assist the African countries which are implementing the ODS alternatives survey to finalize their reports on time so that submission to the Multilateral Fund Secretariat is done on time.

The **specific objectives** of the meeting were to:

- i. Review the status of ODS alternatives surveys preparation including achievements (historical data collected/ analyzed) and challenges.
- ii. Reflect on the results of the ODS alternatives surveys including projections of growth patterns by substance and by sector.

iii. Share approaches and experiences from the ODS Alternatives Surveys preparation.

3.0 Participants

The meeting brought together 29 Ozone officers and national experts of 26 countries conducting the ODS alternatives survey. Experiences and expertise were shared by NOU coordinators, consultants from both the Anglophone and Francophone countries, representatives from UNEP and the Ozone Secretariat.

4.0 Language of the meeting

The meeting will was conducted in both English and French languages. Simultaneous interpretation from English–French was provided during the meeting

5.0 Agenda

The agenda of the three day meeting was as per the attached meeting program (Annex1).

6.0 Opening remarks

The opening remarks were delivered by Patrick Salifu, Coordinator of the Anglophone Network and Yamar Guisse, |Coordinator of the Francophone Network. They both thanked the representatives of the National Ozone Units as well as the consultants for attending the meeting.

They brought to the attention of the participants that:

- i. All countries are required to submit their draft ODS Alternative survey reports to UNEP by 19th December 2016 to the UNEP office and
- ii. Comoros and Zimbabwe would make a presentation of their draft reports to provide some guidance to other countries who are yet to finalize their drafts.

7.0 Presentation: An Overview of the ODS Alternatives Survey Final Report Template (including the Excel Mandatory Tables/Charts to be used)- by Amr M. Abdelhai-OzonAction Branch Programme Officer – UNEP

This presentation covered the following areas:

- ODS Alternative s survey objectives
- Survey Activities: Data collection phase and Data analysis Assessment phase
- ODS Alternative surveys template and content: Executive summary, general
 information, methodology of data collection, section ODS and ODS alternatives and
 analysis of data collected, conclusions and recommendations and mandatory + Excel
 sections respectively

The discussions following the presentation covered the following:

- Countries were advised to validate the data obtained from the suggested sources (Africa Development database and Reegle portal with their respective national data obtained from the data collection tools.
- Countries were advised to ensure that the section of methodology of data collection captures: methods of data collection, geographic scope, duration of the survey and data sources used in the survey.
- Data relating to prices of electricity and other relevant energy information on policy and regulatory framework should be well captured in the report where necessary.
- Description of existing climate related policies and legislations should be included in the report.
- There are many different models for projecting future trends and countries should use the
 model that suits their case There are other factors such as population as well as estimates
 that can determine the model of projection to be used for future consumption of ODS
 alternatives
- The report should be submitted together with the excel tables in one folder.

- Day one of the meeting also included demonstration on how to use excel for analyzing the data on ODS alternatives.
- Zimbabwe and Comoros who had already finalized their draft reports presented the same to provide some guidance to the rest of the countries on how to proceed.
- The afternoon was spent as a working session where each country was expected to continue working on and where necessary to review and revise their draft reports based on the lessons learnt from the presentations and discussions.

DAY TWO

The second day of the meeting was a continuation of the working session where countries worked on their respective ODS alternative draft reports. Alongside this was a presentation on the methods of calculating projections of consumption of ODS Alternatives.

The following issues were raised during this day:

- The method of projection would vary depending on whether the projections are seasonal, quarterly or annually
- Countries should use projection methods/models that are more convergent and those close to reality
- Countries were advised to use excel or focused formula while making their projections. It was noted that excel formula are easy to use as compared to compounded formulas.
- Estimation method adopted by each country should be simple and well illustrated in the report
- Countries were advised to include the table for estimation in the report
- The method of projection used by each country should be guided by the kind of assumption made
- Countries were also urged to show a summary of the procedure of the method used in estimation of future consumption pattern of the ODS alternatives

DAY THREE

Countries continued their working session hours under the supervision of the coordinators of both the Anglophone and Francophone countries. By the end of the day, most countries had advanced greatly in finalizing their reports and were expected to be able to submit their drafts to UNEP by Wednesday 8th December, 2016.

8.0 Closing remarks

Closing remarks were delivered by both the Coordinators of the French and English speaking countries. Both of them were grateful to Mr. Amr Abdelhai for attending and contributing to the workshop. They also thanked the Environmental Compliance Institute (ECI) for organizing a successful meeting in spite of the short notice. They also thanked the participants for taking their time to attend the workshop in order to improve on the progress of the ODS Alternative surveys. Finally, countries were requested to submit their draft ODS Alternative Survey reports by Wednesday 8th December, 2016 in order to ensure that submission to the Multilateral Fund Secretariat is done on time.
